Judge Perry:

I am writing per your request to provide additional information as it relates to matters involving a **Bishop Dr. T.A. Body** (Thomas Alvin Body), who refers to himself as, a) the '**Senior Bishop**' of 'The Church of One Accord', Decatur, GA, and b) '**Prelate**' of the '**Georgia General Fellowship**' and '**Georgia General Ecclesiastical Jurisdiction**', **Church of God In Christ, Inc.**, headquartered in Memphis, TN.

In earlier communications, I noted that I am a former member and minister at The One Accord Church, and served closely with Dr. Body for a number of years in high-level and high-profile capacities. **In Jan 2005, I resigned from this church after observing and uncovering over a period of time, false teaching, deception, and manipulation by T.A Body, his co-pastor wife Darlene Body, and their agents.** After leaving this ministry, I endured defamation and systematic character assassination, interference in my marital affairs, false court testimony against me, malicious prosecution, and other hostilities. After a year of such abuse, I was forced to bring a civil suit for slander, libel, and false light invasion of privacy against the church, T.A. Body, and his co-pastor wife Darlene Body. And per the laws of the State of Georgia, I won this suit by default, as they actively avoided service and failed to answer the complaint. **The aforementioned is thoroughly documented and is available online (see Exhibit 'A').**


Since leaving the One Accord Church almost 4 years ago, I have been made aware of the following facts and/or evidence that can be demonstrated by either personal observation or testimony of witnesses whose names and contact information are to be provided as you requested:

- THAT T.A. Body has been representing himself and accepting monetary contributions/gifts as the representative of a COGIC ecclesiastical fellowship or jurisdiction, which IS NOT INCORPORATED IN THE STATE OF GEORGIA. T.A. Body has also represented himself as a licensed therapeutic counselor, when he is not licensed as such ANYWHERE IN THE U.S.
- THAT T.A. Body has sexually molested at least one female member of his congregation. Now an adult and no longer a member of the congregation, there is one woman who is prepared to go on record to state that T.A. Body had molested her since her youth. Further, she is prepared to state that as recently as July 2008, T.A. Body and Darlene Body contacted her on multiple occasions, attempting to threaten her into silence. **Witness is [REDACTED], and she stands ready to speak to and share evidence with Presiding Bishop C.E. Blake himself in detail. (See Exhibit 'B').**
- THAT T.A. Body and Darlene Body have repeatedly and publicly, defamed former members of The One Accord Church, as well as persons who privately disagreed with their actions or teachings. T.A. Body has even gone so far as to clearly state and/or imply that certain persons in the congregation, who died, did so because of "speaking against" him or the ministry, or for failing to follow his instructions. And Darlene Body has gone so far as to swear out false criminal charges, provide false court testimony, and encourage others to do so. They both have routinely engaged in personal prophesy so as to instill fear in the congregation and to discourage them from freely associating with former church members or other 'outsiders'.
- THAT T.A. Body and his wife Darlene Body have repeatedly interfered in several marital relationships which have ended in divorce. Their actions in this regard include violating confidences and openly berating husbands during church services, advising women to leave and divorce their husbands, paying for a wife's divorce attorney and legal representation, appearing in court with church elders and members so as to influence the court in a wife's favor, assisting and advising wives as to how to take certain legal actions against their husbands.

This, of course, is just the tip of the iceberg. This is clearly an abusive ministry, and has been for a long time. T.A. Body must be stopped.
